Alert Waterloo Region subscription form

Overview

Alert Waterloo Region is a service that allows residents to receive important public safety messages in the event of large scale emergencies such as floods, severe weather, or significant power outages. Notifications can be delivered to home phones, mobile phones, text* and email. *Standard text message rates may apply from your wireless provider

This service will only notify addresses within Waterloo Region and therefore you must subscribe with an address located in Waterloo Region. If you enter an address located outside of Waterloo Region you will not receive notifications.

How is my information used?

The information you provide when you register is collected and used in connection with your use of the service for The Regional Municipality of Waterloo ("Region"), the Police, and Cities and Townships within the Region of Waterloo and will be used to notify the public during large scale emergencies pursuant to the Emergency Management & Civil Protection Act, 1990, s. 3(1). The personal information collected on this form is provided to the Region, Police and the Cities and Townships within the Region of Waterloo, who may also send alerts through this system, both to residents of their own municipality and in some cases to persons outside their municipality. In such cases, they will have access to the information of the individuals to whom their alert is sent. This information may be processed by the Region's third party service provider. This collection of information is in compliance with the Municipal Freedom of Information and Protection of Privacy Act and the Ontario Municipal Act and is under the legal authority of the Emergency Management & Civil Protection Act.
